When registering lambs which have been sold, the seller completes Column 12 and 13. The buyer's name will then be listed as the owner on the front of the Certificate of Registry and the on the front. A complete history of ownership appears on date of transfer will show as the date recorded.

Transfers at time of Registration: Montadales sold Transfers for previously registered Montadales: Owner completes transfer portion on the back of the registration certificate. Give buyer's full name and complete mailing address. For ewes bred at time of sale, supply the Association No. of the ram which serviced them. A new registration paper will be printed with the new owners name the back.

Transfers are mailed to the new owner directly from the Accu-Register office, not back to the Seller. First time buyers will receive a membership package, registry applications, and supplemental information. All Transfers must be mailed in and paid for by the Seller. Transfers sent in by the Buyer will not be processed.
